**Delivery Info:** September 2nd and 3rd or 6th & 7th, from 10:00 am to 5:00 pm at Savoie's Specialties, or Cloverleaf Hall September 8th, noon to 2:00 pm.

An identification label must be fastened securely to bottom back right corner of the quilt (as you look at back) except for challenge quilt. Please see letter for details. The label must contain the full name and address that appears on the official entry form.

**Claim checks** will be given at the time quilt is delivered. Claim checks will be required for quilt pick-up. No quilt will be released without one.

**Pick-Up:** Quilts will be picked-up Sunday, September 11th, between 4:00 pm and 5:00 pm at the Cloverleaf Hall.

**Please note:** An exhibitor wanting a quilt returned by mail must provide postage, insurance and a mailing label.

Please don't enter quilts that have been entered in the HCMD Quilt Show within the past two years.
